Saturday, July 26 - Big Car Derby @ 7:30 pm

Registration begins at 5:00 pm

In the interest of safety, **Drivers, Crews, and Workers** are subject to and must obey the following set of rules including **Vehicle Preparation** regulations on reverse side.

1. Each Driver must fill out an entry form. All drivers must supply their own cars. Only one entry per night per person. Proof of ownership may be requested for each car entered.
2. All drivers and/or pit workers under 18 years of age must have a "release and consent form" signed by their parent or legal guardian (see entry form). **No one under 16 years of age is allowed to participate in the event. (NO EXCEPTIONS).**
3. Cabell County Fair Demolition Derby officials have the right to approve or reject all applications.
4. Cabell County Fair Demolition Derby officials have the right to drill check for plating and concrete.
5. Cabell County Fair Demolition Derby officials have the right to reinspect and disqualify an entry at any time during or after participation.
6. Cabell County Fair Demolition Derby officials have the final say in all decisions.
7. Drivers agree to accept pit conditions as they find them.
8. Any driver or pit worker disobeying the rules will cause that crews car to be disqualified. Unsportsmanlike conduct will be grounds for disqualification and possible barring from future events. **Drivers will be held responsible for the conduct of the entire crew.**
9. The Cabell County Fair Board and its officials are not responsible for any participants cars, parts, or personal property before, during or after the derby events.
10. Vehicles must be in the event staging area and drivers must be signed in at the registration desk one (1) hour prior to race time.
11. **Big Car Derby** - Any American made hardtop automobile or station wagon is allowed. NO trucks, convertibles, jeeps, taxi cabs, limousines, Imperials, or hearses are allowed.
12. **Mini Car Derby** - Any four cylinder two wheel drive automobile is allowed. Maximum wheel base of 104".
13. Titles must be given to fair officials in the fair office for all cars left on the premises for junk.
14. **SALE, POSSESSION, OR USE OF ANY INTOXICATING SUBSTANCE OR BEVERAGE IS STRICTLY PROHIBITED. VIOLATORS WILL BE REMOVED FROM THE PREMISES AND BE SUBJECT TO PROSECUTION.**
15. **SALE, POSSESSION, OR DISPLAY OF FIREARMS AND/OR AMMUNITION, ANY TYPE OF FIREWORKS, OR ANY OTHER ITEMS WHICH MAY CAUSE BODILY INJURY OR LOSS IS STRICTLY PROHIBITED.**
16. **SALE OR DISPLAY OF PORNOGRAPHIC OR SEXUALLY ORIENTED MATERIALS IS STRICTLY PROHIBITED.**
17. **FAIR MANAGEMENT WILL HAVE FINAL SAY IN ANY MATTER REQUIRING ARBITRATION.**

Must be done prior to arriving
At the fairgrounds

- A. REMOVE ALL GLASS INCLUDING WINDSHIELD, SIDE WINDOWS, REAR WINDOW, HEAD AND TAIL LIGHTS. ROLLING WINDOWS DOWN IS NOT PERMITTED.
- B. REMOVE CHROME MOULDING STRIPS AND THE BOTTOM PORTION OF REAR SEATS MUST BE REMOVED. ON STATION WAGONS ALL REAR SEATS AND ECKING MUST BE REMOVED. ALL EXTERIOR FIBERGLASS AND PLASTIC BODY PANELS MUST BE REMOVED (FIBERGLASS NOSE PANELS MAY BE LEFT ON THE CAR).
- C. REMOVE ANY SHARP PROTRUDING FINS OR DANGEROUS OBJECTS MUST BE MASHED DOWN OR CUT OFF.
- D. REMOVE ALL PLASTIC PARTS FROM THE ENGINE COMPARTMENT.
- E. REMOVE OVERFLOW RESERVOIRS.
- F. RADIATORS MUST REMAIN IN THEIR ORIGINAL POSITION OR BE TAKEN OFF.
- G. FANS ALLOWED ONLY IF ORIGINAL EQUIPMENT. **NO ELECTRIC FANS IN BIG CARS.**
- H. NO SPECIAL BUMPERS, REINFORCEMENTS, FABRICATIONS, CONCRETE, OR TRAILER HITCHES ARE PERMITTED.
- I. ROLL BARS ARE PERMITTED BEHIND THE FRONT SEAT ONLY WITH FRONT SUPPORT BRACES. NO ROLL CAGES.
- J. ALL DOORS MUST BE FASTENED SHUT BY WIRE, STRAPS, OR CHAINS FOR THE DRIVER'S SAFETY.
- K. ONLY ONE BATTERY, ANY SIZE, IS ALLOWED. THE BATTERY MUST BE PLACED ON THE FLOORBOARD OF THE PASSENGER SIDE AND SECURELY FASTENED AND COVERED.
- L. CUTTING FENDERS FOR WHEEL CLEARANCE ONLY IS PERMISSIBLE AND ENDS OF BUMPERS MAY BE CUT OFF. BUMPERS MUST BE SECURED WITH ORIGINAL EQUIPMENT BOLTS AND BRACKETS EXCEPT ON CARS WITH SHOCK TYPE BUMPER MOUNTS. ON THESE WE RECOMMEND WELDING BUMPER MOUNTS TO THE FRAME AND BUMPER BAR.
- M. HOOD, TRUNK, OR TAILGATE MUST BE WIRED IN FOUR (4) PLACES EACH WITH TWO (2) STRANDS OF WIRE PER HOLD. WIRING MUST BE FROM SHEET METAL TO SHEET METAL. NO OTHER WIRING TO BUMPERS OR FRAMES. OFFICIAL'S DECISION ON THE EXCESS USE OF WIRE IS FINAL. NO BANDS, BOLTS, PINS, OR CABLES CAN BE USED. **NO WELDS ON HOOD, TRUNK, OR TAILGATE. NO SEAM WELDS.** HOOD AND TRUNK MUST BE LEFT OPEN UNTIL AFTER INSPECTION IS COMPLETED. HOOD MUST REMAIN ON CAR.
- N. DOORS MAY BE WLEDED BY 3" WIDE BY 5" LONG STEEL STRIPS WITH GAP BETWEEN OF AT LEAST 5". NO WELDING DOORS TO FRONT FENDERS AT ALL. **IF WELDED AT ALL, CAR WILL NOT BE ALLOWED TO RUN.**
- O. BOTH FRONT DOORS MUST BE PAINTED WHITE FOR SAFETY AND NUMBERING. SPECIAL NUMBERS ARE PERMITTED. NO PROFANITY WILL BE ALLOWED ON ANY PORTION OF THE VEHICLE.
- P. STOCK GAS TANKS MUST BE REMOVED FROM THE ORIGINAL POSITION AND PLACE IN FRONT OF THE REAR AXLE AND NO FARTHER FORWARD THAN THE REAR OF THE FRONT SEAT. ALL TANKS MUST BE SECURELY FASTENED TO THE FLOOR AND COVERED. A PORTABLE TANK IS RECOMMENED IN PLACE OF THE ORIGINAL. GAS LINES AND FITTINGS TO THE FUEL TANK MUST BE SECURED AND LEAK PROOF. ONLY METAL OR RUBBER GAS LINES ARE PERMITTED. **NO PLASTIC LINES!**
- Q. AUTO MUST BE SWEEPED CLEAN. NO JUNK TIRES, WHEELS, METAL PARTS, BROKEN GLASS, ETC. ALLOWED INSIDE OF THE CAR.
- R. **LIFT KITS OR WEDGES IN THE SPRINGS ARE NOT ALLOWED. NO ALTERED OR AIR SHOCKS. (THIS WILL BE ENFORCED) - THERE MUST BE SOME GIVE 1-2 INCHES.**
- S. THE DRIVER'S DOOR MAY BE REINFORCED WITH STEEL BAR, ANGLE IRON, OR PIPE. LENGTH IS NOT TO EXTEND MORE THAN EIGHT (8) INCHES ON EITHER SIDE OF DRIVER'S DOOR. INSIDE DOOR PANEL SHOULD BE LEFT INTACT OFR YOUR PROTECTION.
- T. IT IS MANDATORY THAT AN OPENING BE CUT IN THE HOOD ON THE PASSENGER'S SIDE, APPROX. EIGHT (8) INCHES IN DIAMETER. HOOD LATCH MUST BE REMOVED (LEAVE THE HINGES ON).
- U. BIG CAR TIRE SIZE LITMED TO 235 X 15. MINI CAR LIMITED TO 14" WHEELS. NO STUDS OR SCREWS IN RIMS TO HOLD TIRES. NO VALVE STEM PROTECTORS. AIR ONLY IN TIRES (NO FOAM FILLS OR FLUID OF ANY KIND PERMITTED; NO LINERS OR DOUBLE TUBES PERMITTED).
- V. ALL HOLES BETWEEN ENGINE COMPARTMENT AND DRIVER'S COMPARTMENT SHOULD BE CLOSED WITH METAL OR CAULKING.
- W. SAFETY SEAT BELT, Z-90 APPROVED HELMET, AND GOGGLES OR FACE SHIELD ARE REQUIRED.
- X. WHEELS MUST BE STOCK WITH NO MODIFICATION.
